



**BUYER BROKER PARTICIPATION AGREEMENT & REGISTRATION FORM**

Property Location: **9029-16<sup>th</sup> Avenue, North Battleford, SK S9A 2T6**

Auction Date: **October 9, 2010**

**To receive a 2% (two percent) Commission on the successful bid for this property, a Broker/Registrant MUST:**  
- register his or her Buyer/Bidder by filling out this form, in full, & fax, mail or bring it to **Kramer Auctions – Real Estate Division Inc** to be received **as soon as possible** in our office for verification, but **no later than 5:00 p.m. Thurs, Oct 7, 2010.**

- \* Broker/Registrant must show the property in person to his or her Buyer/Bidder.
- \* Broker/Registrant must provide his or her Buyer/Bidder with comparable market information.
- \* Broker/Registrant must familiarize his or her Buyer/Bidder with property details plus all Auction terms & conditions.
- \* Broker/Registrant must attend and register with his or her Buyer/Bidder at the auction and encourage bidding.
- \* Broker/Registrant agrees that no oral registration will qualify Broker for commission.
- \* Broker/Registrant agrees that Broker will not be entitled to a commission, if Broker or any member of Broker's family or firm participates, as a principal at the Auction. Broker shall give an affidavit to this effect, if requested.
- \* Broker's/Registrant's Buyer/Bidder must be the high bidder on the property and the bid must be accepted by the Seller.
- \* Broker's/Registrant's Buyer/Bidder must sign the real estate contract immediately following the auction of the property.
- \* Broker's /Registrant's Buyer/Bidder must make payment of the deposit money as per terms & conditions at contract signing.
- \* Broker's /Registrant's Buyer/Bidder must close on the property within 30 days from the auction date **unless otherwise arranged.**
- \* Broker/Registrant agrees that Broker's commission will be due upon final closing of the purchase by his or her Buyer/Bidder with all consideration paid in full.
- \* Broker/Registrant agrees that only the first registration of a prospective Buyer/Bidder will be accepted and honored.
- \* Broker/Registrant is allowed only one Buyer/Bidder per auction event.
- \* Broker/Registrant agrees that commission will ONLY be paid and disbursed at time of closing.
- \* Broker/Registrant agrees to hold harmless and indemnify **Kramer Auctions – Real Estate Division Inc** including its reasonable attorney's fees, from any and all claims with regard to such commission.
- \* Broker/Registrant must bring all forms that their office requires, to the auction, to be reviewed and/or signed at the signing of the real estate contract.
- \* Broker/Registrant must have Bidder sign this form acknowledging representation.

No Broker will be recognized on a prospect who has previously contacted Seller or **Kramer Auctions – Real Estate Division Inc** or has been previously contacted by Seller or **Kramer Auctions – Real Estate Division Inc**. A complete registration file on all prospects will be maintained. There can be **NO EXCEPTIONS** to this procedure and no oral registrations will be accepted.
